

stablished as the Russian Institute in 1946, the Harriman Institute at Columbia University is ■ one of the world's leading academic institutions for the study of Russia, Eurasia, and Eastern Europe. In 1982, the Russian Institute became the W. Averell Harriman Institute for the Advanced Study of the Soviet Union, in recognition both of Governor Harriman's generous endowment of the Institute and his lifetime of distinguished service. Throughout the years our faculty and alumni have made important contributions to academia, and have also played leading roles in public policy, law, diplomacy, business, and the arts. Notable among them are former head of the National Security Council, Zbigniew Brzezinski; former Special Advisor to the Secretary of State, Marshall Shulman; former Ambassador to Russia, Jack Matlock; and former Secretary of State, Madeleine Albright. The Institute currently houses a diverse multidisciplinary faculty from Columbia's School of Arts and Sciences, Barnard College, the schools of International and Public Affairs, Business, Law, and the Arts, Teachers College. We support teaching, research, and public events that bring together our extraordinary faculty,

students, and alumni. From "brown bag" lectures, book presentations, art exhibitions and film screenings, to scholarly panels and conferences, the Institute provides a constantly evolving forum for intellectual discussion and innovation.

In addition to offering undergraduate and graduate courses, the Institute administers an MA program in Russian, Eurasian, and East European Studies, which admits approximately 10 students per year. We are committed to training the next generation of regional specialists, who will continue to shape policy, fill leading academic positions, and challenge the accepted truths about how we study our rapidly changing world. # LETTER FROM the director

Booker. While at Columbia, he taught the course "Postmodernism vs. Tyranny: A Romanian Literary Revolution," and held a public reading in conversation with his translator Sean Cotter. We were honored to have Cărtărescu join the ranks of our Harriman writers.

Another important initiative we continued this year is the Klebnikov Global Fellowship for Russian and Belarusian Media in Exile. Tailor-made for the post-2022 political reality, this program addresses the specific needs of exiled media outlets and is thus the perfect addition to our Klebnikov Russian Civil Society Fellowship that focuses on individual journalists. This summer, we successfully launched a pilot online program of the new fellowship, led by Keith Gessen and Andrew Meier in partnership with Columbia Journalism School and the JX Fund. We are committed to continuing our support, led by the conviction that Russophone independent media is a crucial resource for navigating today's disinformation landscape and, thus, directly contributes to the Harriman Institute's research and educational missions.

This year we also celebrated the conclusion of a long-term Harriman project focused on advancing studies of Russia across the social sciences at Columbia and beyond. Made possible by a grant of over \$2 million from the Carnegie Corporation of New York and led by former Harriman directors Alexander Cooley and Timothy Frye, with Elise Giuliano, Jack Snyder, Kimberly Marten and myself as co-PIs, this project has been a real boon to the Institute. For nine years, it has allowed us to foster cutting-edge education and research on Russia, precisely at a time when such studies have been seriously impeded by decline of civic and academic freedoms in Russia and escalation of U.S.-Russia hostilities. We are planning a final capstone event for September 2025 to mark the conclusion of this impactful grant cycle with a major international conference on decolonizing Russian Studies.

Most importantly, in the fall we welcomed a vibrant new cohort of nine MARS-REERS students who came to us from Kyrgyzstan and Lithuania, from completing Fulbright programs in Moldova and Azerbaijan, and from Bakhmut where they have assisted in the evacuation of Ukrainian residents. The diversity of their interests is classic Harriman—ranging from human rights and security to history, literature, and musicology. It's been a pleasure getting to know them this year.

I would like to emphasize that having such impressive student cohorts year after year would not

have been possible without the financial support we continue to receive from many individual donors among you. Your generosity is crucial for the success of our educational mission, for the excellence of the Harriman MARS-REERS program, and for the Institute's commitment to the best students and scholars working on our region in these critical times. We are all in your debt!

The 2024–25 academic year was the last of my current term as the Harriman Director. It was a whirlwind of a term, full of challenges, transformative events and unforgettable experiences. We managed to accomplish a lot together, despite all difficulties, and it has been such a privilege to be part of the team.

I am deeply honored that the members of the Executive Committee elected me for another term, to begin in 2026. In the meantime, I will take a sabbatical to work on a monograph about the militarization of Russian Christianity under Putin, with a residential fellowship at Columbia's Institute for Ideas and Imagination in Paris. I am profoundly grateful to my colleague Jack Snyder, who will lead the Institute as Acting Director while I am away.

I urge you to read about our rich calendar of events and programs in the body of this annual report. I am proud of the work we have done and trust that the upward trajectory of the Harriman Institute will continue next year under Jack's capable leadership!


# STUDIES OF the harriman





## **CURRENT PRINT ACQUISITIONS**

In FY24, Columbia received 8,017 new Slavic, East European and Eurasian-language titles in traditional formats via our approved vendors. Distributed over a wide range of languages, the four largest languages for intake are Russian (more than 1,800 titles), Bulgarian (900), Bosnian (853), and Romanian (900).

Ukrainian intake included 534 recent titles from our principal vendor, Alexandra Isajevych. That puts us ahead of FY 2023, but behind FY 2022, before the impact of the invasion on publishing was fully apparent.

In addition, Cornell received on approval 3,903 new vernacularlanguage print titles, of which the majority were Russian (2,011), Romanian (440), and Serbian (484). All of these figures exclude counts for materials firm-ordered at the request of faculty or students, nor do they include serial or gift material. Nor do they include intake for non-Slavic & East European language material pertaining to the region.

Acquisitions budgets have remained steady at both institutions, which is no small feat given the campus disruptions and added financial burdens of the past year.

However, retirements and resulting fallow positions in tech support services, as at other institutions, raise concerns regarding our ability to process new acquisitions. Most especially in some of the less-commonly taught languages. Increasingly we are looking towards greater vendor involvement in the provision of quality cataloging records and "shelf-ready" materials.

#### **ELECTRONIC RESOURCES**

As mentioned in previous 2CUL Newsnotes, we are constantly expanding access to e-books, specifically from Russia and Ukraine. In the case of Russian materials, this enables us to avoid tariffs levied on print materials physically brought to the U.S., and enables us to avoid duplicative acquisitions by focusing on certain high-profile publishers in e-format and NOT acquiring print copies.

Through EastView's e-book program, we gained access to 567 Russian academic press titles not otherwise held in print, and 338 Ukrainian titles with 2023–2024 imprint dates. Cornell affiliates use of e-books increased a robust 5.4% to 741 users consulting 654 items in the past FY; Columbia's e-usership decreased slightly.

Robert Davis is delighted to report that Columbia affiliates now have access to a second database

of Russian e-books, BiblioRossica, a project of Academic Studies Press in Boston. It describes itself as a "digital library for academics and scholars that offers expertly selected collections devoted to the most relevant areas of modern Slavic and Tewish Studies. Our ever-growing collection includes over 24,000 titles of scholarship, with thematic collections spanning works in history, philosophy, linguistics, art, sociology, and more. Most of these books don't reach readers outside Russia and are not available online. New titles become available shortly after print publication, along with the most significant books from recent years."

Coverage is particularly strong for modern fiction, as well as in areas such as business, cooking, language instruction, textbooks, etc. that are not represented in the more strictly academic EastView e-book approval offerings.

In the area of digital databases, Columbia acquired from EastView the digital archives for:

- <u>V Novom svete</u>. Founded in 1995, it was the most popular weekly newspaper in the Russian-American community for 27 years.
- Znamia. Originally launched in January 1931 under the name LOKAF, an acronym for the Literary Association of the Red Army and Navy, the journal was officially rebranded as Znamia in 1933. In 1986, Znamia underwent a significant transformation, evolving into one of Russia's most widely-read literary journals and serving as a herald of the Perestroika movement.
- Izvestiia RAN. Seriia literatury i iazyka. Published by the Soviet/Russian Academy of Sciences since 1940, with a

- focus on research in the fields of literature, linguistics, and philology.
- Acquired jointly with the Starr East Asian Library, the digital backfile for *Far Eastern affairs*. Published since 1972 by the Russian Academy of Science's Institute for China & Contemporary Asia, this Russian journal-translated into English-provides multidisciplinary content on the histories, cultures, politics, and economics of China, Japan, the Koreas, and Southeast Asia through a Russian lens.

Columbia also added access to *Encyclopedia of Slavic Languages* and *Linguistics Online* (Leiden: Brill, 2020–).

## ANTIQUARIAN PURCHASES

Columbia purchased seventeen issues of *Radians'ke mystetstvo* (Kyiv, 1928–1932) published by the Kyiv District Trade Union Council, with the stated objective of being a political and propaganda weekly covering theater, drama, rural clubs, and other cultural activities in the area. Several issues have striking photomontage cover designs. Copies are quite scarce, with OCLC finding no institutional holdings worldwide.

Also, just acquired with the assistance of the Primary Resources Fund was a unique collection of eight albums containing 826 mounted photographs, dated ca. 1881–ca. 1913, taken by French and German expats living in prerevolutionary Russia. The albums document life and activities of several Moscow-based expat families, who were involved in the local small businesses and enterprises, factory owners. One family owned the chemical factory

'Karl Bloesch,' which existed in Moscow from the 1890s until 1919 when it was nationalized. Another factory featured in the photos is the French-owned, Moscow-based paint factory of G. Lombard.

Depicted are businesses, including factories and the locals who staffed them, photos of historical events, landmark architecture and a variety of photos of Russian scenery and people in various occupations. Also depicted are scenes from a village close to Perm, mining encampments in the Ural mountains, street scenes of Batumi and Sebastopol, Yalta and Constantinople.









Album VIII includes photos of Moscow after the 1905 revolution, as well as photos of the militia on the streets of Odesa during the uprising.

This acquisition directly complements existing Russian photographica held by the Bakhmeteff, initially documented by Hee-Gwone Yoo in "Russian, Soviet and East European Photographs in the Rare Books and Manuscript Library, Columbia University: A Note on Albums," Slavic & East European Information Resources, 23(1–2): 208–227 (2022).

**Columbia's** Manuscripts and Archives holdings also expanded during the spring semester.

- The Paul H. Aron (1921–1991)
  Papers. He was an economist
  who was an authority on
  Japanese investments, served
  as a Russian-English interpreter
  for the American, British and
  Russian members of the Allied
  Control Commission for Austria.
- The Leonid Plyushch (1939–2015)

  Papers, 1970–2015, "consists
  of books, correspondence,
  documents, drafts, manuscripts,
  periodicals, photographs and
  printed material. The papers
  document the life and work of
  Plyushch, a Ukrainian political
  activist and mathematician, a
  member of the Initiative Group
  for Human Rights in the USSR
  and a victim of Soviet punitive
  psychiatry."
- The General Belá Király
  (1912–2009) Papers, 1950s–1980s,
  "include personal and
  professional correspondence,
  manuscripts, and materials
  related to two organizations
  he was involved with, the
  Hungarian Freedom Fighters
  and the Program on Society in
  Change. The papers are from
  Király's time in the United States
  (circa 1957 to 1989)."

Improved finding aids are now available for:

- The Konstantin Ivanovich Globachev Papers, 1880-1958. Globachev was chief to the Petrograd Department of the Okhrana, the Tsarist secret police, in the two years preceding the 1917 Russian Revolution. Included are his correspondence typescript memoirs, personal documents, copies of photographs and biographical materials. Globachev's memoirs give a detailed account of events in Petrograd in the period 1914-1920.
- The Aleksei Fedorovich (1871-1958) and Liubov Aleksandrovna (1885-1964) Girs Papers, 1913–1963. Girs graduated from the Corps of Pages and started his military career at the Preobrazhensky Regiment, in which he served for ten years until he left military service. He began his civic activity as Marshall of district nobility in the city of Kovno, and then in the Minsk provinces. From 1909, he served as governor of Kyiv when there was an attempt on Stolypin's life. Transferred to Minsk as governor from 1912 to 1915. In 1915, Girs was governor of Nizhny Novgorod. The Girs family emigrated to Estonia, and in 1924, they moved to France.
- Political Printed Ephemera, 1875–1922. "Most items concern various political and revolutionary groups, such as the Russian Social Democratic Labor Party (RSDRP), the Party of Socialist-Revolutionaries (PSR), the Jewish socialist Bund, the Polish Socialist Party, and the Anarchist-Communists. The materials document activities of the organizations and include flyers, leaflets, event announcements, newsletters, appeals, articles, bulletins, etc. The bulk of the material was printed in western Europe in the

period 1906–1914; later materials chiefly concern Russia in 1917–1930. There are also handwritten materials, including meeting notes and agendas. While most materials in the collection are in Russian, there are also items in Polish, Yiddish, Ukrainian, German, and French."

Columbia's **Burke Library** at Union Theological Seminary processed <u>YMCA and YWCA</u>

Records, 1925–1949. The collection includes pamphlets, questionnaires, records, and history of the Y in different parts of the world including Czechoslovakia and Poland.

#### **GIFTS**

Columbia Business School alumnus **Grigor Acenov**, and **Goryana Lenkova** donated a collection of titles translated into Bulgarian by the distinguished poet Grigor Lenkov (1938-1977).

Dr. David Aubrey, a former Senior Scientist from the Woods Hole Oceanographic Institution donated a large collection devoted to the Black Sea and Caspian Sea regions. He had previously headed UNDP/World Bank projects in both regions. Some 198 titles represented additions to the Columbia and ReCAP collection.

Jeri Laber, a founder and Executive Director of Helsinki Watch (later Human Rights Watch), donated additional materials pertaining to the organization's early activities in the Soviet Union.

Natalya Bernadskaya of The New Review/Novyi zhurnal donated Biryuzovy dozhd (Kyiv: Summit-Book, 2021) by New York author Polina Breyter (born in Odesa, Ukraine), and Vremya Surka (Moscow: "Vremya," 2022) by Vladimir Grjonko (born in Baku, Azerbaijan).

The children of **Professor Cynthia Hyla Whittaker** donated

her collection to Columbia, which included thirteen 18th- and 19th-century imprints lacking in our holdings, among them *Kratkoe opisanie Rossiskago Gosudarstva* (Saint Petersburg, 1787); and the rare journals *Utrenniaia zaria* for 1841 and 1843, and [Sievernaia?] *Minerva: zhurnal* (1807).

Barnard alumna **Dr. Molly Wesling** donated five examples of samizdat poetry produced by Sasha Bogdanov. Specifically, "Chellendzher kommunizma," "Dorogaia Raisa Maksimovna!," "Mavzoleinoe," "Rossiia 1989," and "Za Rodinu! Za Stalina! Za Ligachëva!" All were published in Leningrad by the Vol'naia



rossiiskaia tipografiia. Dr. Wesling bought the items from the poet onsite in St. Petersburg in 1989.

Mark Haag donated two early 19th century Russian imprints that represented lacunae in our holdings: Evgenii (Bolkhovitinov), Metropolitan of Kyiv & Galicia (1767–1837) Slovar' istoricheskii o byvshikh v Rossii pisateliakh dukhovnago china, Grekorossiiskoj tserkvi (Saint Petersburg: Tip. N. Grecha, 1818), and Sochineniia V.A. Ozerova, Ch. I & II (Saint Petersburg: Ivan Glazunov, 1816–1819).

As in past years, **Paul Michael Taylor** has given Columbia both
Central Asian, and Ukrainian titles

that are not widely held by peer libraries.

The Abraham J. Heschel Center for Catholic-Jewish Relations at the John Paul II Catholic University of Lublin donated the book Wartime Rescue of Jews by the Polish Catholic Clergy: The Testimony of Survivors and Rescuers, compiled and annotated by Ryszard Tyndorf with the assistance of Zygmunt Zieliński (Lublin: Wydawnictwo KUL, 2023).

## CURRENT APPROVAL ACQUISITIONS

At the halfway point of the Fiscal Year, our mostly-in-country vendors continue to send along carefully selected materials according to our subject profile. As of this writing, Columbia has received from Botimpex (Tirana): 336 titles; Bouchal (Budapest) 144; Derex (Bucharest) 403; EastView (Minneapolis, but with offices throughout the former Soviet

Union) 363; Isajevych (Kyiv/Lviv) 288; Kozmenko (Moscow/Erevan) 709; Lexicon (Warsaw) 101; MIPP (Vilnius) 67 (most in Russian); Regula Pragensis (Prague) 112; Serbica (Toronto) 67; Sofia Books (Sofia) 503; and University Press (Sarajevo) 438. To date, these represent an expense of \$138,473 at a per-unit average of \$39.62. Cornell has thus far received 795 titles from Kozmenko, 116 from MIPP (mostly Russian), 135 from Serbica, and 649 from EastView (in various languages).

#### **ELECTRONIC RESOURCES**

Columbia added a newly-published ProQuest module (Collection 63) of the Digital National Security Archive (DNSA-63): *U.S.-Russia Relations: From the Fall of the Soviet Union to the Rise of Putin, 1991-2000.* According to its published description:

"This curated collection of documents covers the formative period of U.S.-Russian relations from the birth of the new Russia in December 1991 through January 2001. It captures the highest peaks of cooperative relations under presidents Boris Yeltsin and Bill Clinton as well as the first notes of discord under Vladimir Putin. The product of years of archival research and hundreds of targeted Freedom of Information Act requests, this unparalleled collection features a full set of memoranda of conversations between Yeltsin, Putin, and Clinton; correspondence between the top leaders; hundreds of high-level memos from members of the Clinton administration; and analyses and assessments of the defense capabilities of the new Russia. Among other core topics, the set closely tracks negotiations on nuclear arms reductions, nonproliferation, and the withdrawal of nuclear weapons from Ukraine, Belarus, and Kazakhstan and their dismantlement in Russia. The collection also covers the Russian wars in Chechnya and Russian participation in peacekeeping in the former Yugoslavia. Many documents deal with one of the most controversial issues in U.S.-Russian relations - the expansion of NATO to Eastern and Central Europe."

Robert Davis is also at this very moment in the process of acquiring access to two interesting electronic resources for Columbia. The first is a searchable AI-generated English translation of the long-running journal *Iskusstvo kino* (Moscow, 1931–2023), which will open the content of the journal to readers without a knowledge of Russian.

The second is a collection of forty-seven Russian-language newspapers, 2014–2023, published in the occupied territories of Eastern Ukraine. A description is found here.

Both resources will be available to current affiliates via the EastView platform.

Enerel translated, edited, and compiled this book to accompany an exhibition in Ulaanbaatar, Mongolia, to commemorate his 100th birthday.

Cornell's President White Professor of History and Political Science (*Emeritus*) **Matthew Evangelista** donated rare titles picked up in Tomsk some two decades ago.

The majority of this collection consists of books with inscription of significant scholarly value. Some of those inscriptions may shed light on the creative methods of Russian dissident poets."

#### Harriman Human Rights Advocate: Bojana Jokić

President of the Board of Directors; LGBT Forum Progress (Montenegro)

Founded in 1989, the Human Rights Advocates Program (HRAP) is a unique and successful model of human rights capacity building. HRAP capitalizes on its affiliation with Columbia University and its location in New York City to provide grassroots leaders the tools, knowledge, access, and networks to strengthen their organizations and promote human rights.

HRAP's comprehensive program of advocacy, networking, skills-building, and academic coursework provides advocates the opportunity to hone practical skills, develop a deeper understanding of human rights, and foster mutually beneficial relationships with organizations and individuals in their fields.

Bojana Jokić has been the President of the Board of Directors of LGBT Forum Progress since 2016. The mission of LGBT Forum Progress is to create a safe, inclusive, and stimulating environment in Montenegro for all LGBTQI+ people through community development, social and health protection, political and economic participation, representation and advocacy. Bojana has been a member of the National Team for Coordinating the Implementation of the Strategy for Improving the Quality of Life of LGBTI Persons in Montenegro, the Trust Team of the LGBT Community and the Police Directorate, the Ministry of Human and Minority Rights' Commission for Allocating Funds for Financing NGO Projects/Programs in the area of "protection and improvement of human rights of LGBTI persons," and the team for monitoring hate speech on the internet.

### Paul Klebnikov Civil Society Fellowship: Farida Rustamova

The Paul Klebnikov Civil Society Fellowship helps bring to the Harriman Institute highly qualified Russian journalists and civil society professionals who are known for their independence, integrity, and objectivity. The Institute arranges an extensive visit with experts, policymakers, and professionals in New York to benefit the fellows and their work in Russia.

The Fellowship is made possible by a generous gift from Mrs. Paul Klebnikov and the Paul Klebnikov Fund. The program honors the memory of Paul Klebnikov, the American journalist and editor of *Forbes* Russia who was assassinated in Moscow in 2004.

Farida Rustamova has been working in political journalism for more than 10 years. She has worked at the most prominent independent media in Russia (*RBC*, *Meduza*, *TV Rain* (*Dozhd*), *BBC* Russian Service). As a correspondent, Rustamova has worked on articles and investigations about Putin's family, high-ranking officials, and other members of the political elite. Rustamova worked for several years as a reporter in the Russian parliament and government. Her essays were published by *The New York Times* and *Financial Times*. Since the beginning of the war in Ukraine she has been running *Faridaily*, a media project focused on Russian power.



# POSTDOCTORAL SCHOLARS & faculty research

The Harriman Institute postdoctoral fellowships allow junior scholars to spend a 2-year term in residence at Columbia University in New York. All scholars are assigned a faculty mentor. Postdoctoral scholars are expected to concentrate on their own research and writing; to give a brownbag seminar on their research; teach one course; and to be active participants in the Institute's scholarly community and events. The Institute provides funds to sponsor workshops, conferences, and special events planned by scholars around their particular interests.



#### **Alexandra Birch**

Mellon Teaching Fellow at the Harriman Institute; Lecturer in History

Dr. Alexandra Birch is a professional violinist and historian who works comparatively on the Nazi Holocaust and Soviet mass atrocity, including the Gulag, through the lens of music and sound. She holds a Ph.D. in History from the University of California Santa Barbara. Previously, she was a fellow at the US Holocaust Memorial Museum, the Wilson Center, and the Vienna Wiesenthal Institute, where she released CDs of recovered music and finished her first book *Hitler's Twilight of the Gods: Music and the Orchestration of War and Genocide in Europe*.



#### **James Meador**

Mellon Teaching Fellow at the Harriman Institute; Lecturer in Anthropology

Dr. James C. Meador is a linguistic anthropologist and anthropological historian of Sino-Russian borderlands studying social semiotics of empire. Their work examines Russian, Chinese, and Manchu language materials to understand imperial diversity through processes of contact and social transformation. Their dissertation project "Making Chinese Orthodox" reconstructed the origins and union of two independent traditions of Orthodox Christianity in China through the bilateral Russian and Chinese state-sponsored revival of the Chinese Autonomous Orthodox Church. They hold a Ph.D. in Anthropology from the University of Michigan.



#### **Renata Mustafina**

Postdoctoral Research Scholar in Russian Politics

Dr. Renata Mustafina is a law and society scholar with research interests in authoritarian legality, legal mobilization, and defense lawyering in repressive settings, as well as in critical approaches to human rights. Her book manuscript, tentatively titled "Against Impossible Odds: Defensive Legal Mobilization in Russian Protest-Related Prosecutions," ethnographically studies the legal aftermath of opposition protests. She holds a Ph.D. in Political Science from Sciences Po.



#### **Stefan Szwed**

Marie Curie Global Postdoctoral Research Fellow

Dr. Stefan Szwed is Marie Curie Global Fellow at the Harriman Institute and Ca'Foscari University of Venice. His research project, "Democracy Support Practice After the Third Wave: Adapting to Change?" focuses on the effectiveness of election observation by intergovernmental and international nongovernmental organizations. He was Fellow in Rule of Law and Democracy at International IDEA in Stockholm and European University Institute in Florence, and previously Research Associate at the Department of Politics and International Relations at Oxford and Mairie de Paris Postdoctoral Fellow at the Centre de recherches internationales (CERI) at Sciences Po. He holds a D.Phil. (doctorate) in International Relations from Oxford (St. Antony's College).



#### Anastasiia Vlasenko

Petro Jacyk Postdoctoral Research Scholar in Ukrainian Studies; Lecturer in Political Science

Dr. Anastasiia Vlasenko is the Petro Jacyk Postdoctoral Research Scholar in Ukrainian Studies. She is a recent HURI Research Fellow at Harvard's Ukrainian Research Institute and a recent Postdoctoral Fellow at the NYU Jordan Center for the Advanced Study of Russia. Vlasenko studies legislative politics and democratization with a specialization in the politics of Ukraine. Her monograph project, "Legislators in Networks: Corruption, Clientelism, and Law Making" investigates how legislative networks formed through parliamentary aids can affect rent-seeking behavior in the Ukrainian parliament. Vlasenko received her Ph.D. from the Department of Political Science at Florida State University in 2022.



#### **Taylor Zajicek**

Mellon Teaching Fellow at the Harriman Institute; Lecturer in History

Taylor Zajicek is a historian of Eurasia, the Middle East, and the places that unite them. Zajicek's writing is based on archival research in six languages across seven countries. This fieldwork has been sponsored by various external grantors. At the Harriman Institute, Zajicek is also working on a desert history of Central Asia and a digital humanities analysis of 1,300 Soviet conservation posters. Zajicek earned his Ph.D. from Princeton University in 2023.





# WRITER in residence

#### Mircea Cărtărescu



The Harriman Institute's Writer in Residence Program brings renowned writers from Russia, Eurasia, and Eastern Europe to Columbia for an extended visit. The initiative was launched in 2013 by graduate students from the Department of Slavic Languages eager to discuss literature with living authors from the region. Writers in Residence teach a short course, meet with students and faculty, and participate in notable public events that allow the writer to present their work to a broader audience and to facilitate a cross-cultural dialogue.


Mircea Cărtărescu, awarded the Dublin Literary Award (2024) for his novel *Solenoid*, has won over 20 international prizes, including The *Los Angeles Times* Book Prize (2023), The FIL Prize (2022), The Thomas Mann Prize (2018), The Austrian State Prize (2015), The Mondello Prize (2024), and The Formentor Prize (2018). He is a poet, novelist, literary critic, journalist, Professor Emeritus at the University of Bucharest, member of the Romanian Writers' Union, Romanian PEN and the European Cultural Parliament. He has published over 40 books and a large number of articles. Cărtărescu's work has been translated into over 25 languages.

He is Doctor Honoris Causa of the Universities of Constanța, Bacău, Cluj, Timișoara, of the Faculty of Medicine in Bucharest, and the International University Menendez Pelayo in Santander, Spain.

At the Harriman Institute, Mircea Cărtărescu taught the four-week course "Postmodernism vs. Tyranny: A Romanian Literary Revolution."



#### Sonic Shatterzones: Hearing the Intertwined Spaces and Music of Nazi and Soviet Atrocity

**DIRECTOR'S SEMINAR SERIES**

**Alexandra Birch** (Mellon Teaching Fellow at the Harriman Institute; Lecturer in History)

In four case studies, Birch provided examples of how we can hear the Holocaust, the Gulag, Terror, and exile. She discussed Weinberg's sonic fragments taken to Tashkent and covertly buried in his violin sonata during a peak of Soviet antisemitism in 1948. These pieces describe the Gulag between field recordings of Karlag and the recovered music of Nosyrev and Zaderatsky, look at the overlap between Nazi and Soviet occupation of indigenous space, and discuss how we can hear the Holocaust in the Soviet context with recovered music and through sound



## Election Debrief: What Will a Second Trump Term Mean for US-Russia Relations?

This panel discussion with foreign policy experts and academics explored the potential impact of a second Trump presidency on US foreign policy toward Russia. Key questions included: How could these results shape US support for the war in Ukraine? Might Donald Trump transform US sanctions policies? What implications could there be for NATO?

#### DEMOCRACY IN CRISIS AND TRANSFORMATION

Launched in Spring 2025, a new series of webinars, "Democracy in Crisis and Transformation," offered perspectives on hot political issues from across our region. Nutsa Batiashvili, la Eradze, Tamta Khalvashi, and Luka Nakhutsrishvili discussed Georgia's post-election crisis and mass resistance.

Nadia Shabani, Zahari Iankov, Dávid Vig, Peter Čuroš, and Atanas Politov discussed warnings and lessons about the changing environment for civil society in Hungary, Slovakia, and Bulgaria. The series sought to engage an international audience in a focused continuous conversation, and was especially addressed to the diverse community of Harriman alumni around the globe.

The 2025 George Shevelov Memorial Lecture was given by Rory Finnin. Finnin discussed the Crimean Tatars, who are recognized as an indigenous people of Ukraine. He also explored the literature and culture of this Crimea hidden from our view, paying special attention to key Crimean Tatar and Ukrainian writers.



#### The Cold War, Russia-China Relations, and the Making (and Unmaking?) of Southeast Asia

**BORTON-MOSLEY DISTINGUISHED LECT. SERIES**April 8, 2025

**Bilahari Kausikan** (Former Ambassador-at-Large, Ministry of Foreign Affairs of Singapore, former Chairman, Middle East Institute, National University of Singapore) Southeast Asia is not a natural region but a geopolitical construct. ASEAN defines the region, and it was profoundly influenced by Cold War dynamics as they played out in Southeast Asia. What does a Cold War organization do after the end of the Cold War? Furthermore, how does ASEAN operate after it expanded to include Vietnam, Laos and Cambodia which were mired in Cold War proxy civil wars and in which the communist or proto-communist parties emerged victorious?



Russia After Putin

April 25, 2025

Organized by **Elise Giuliano** (Columbia University) and **Kimberly Martin** (Columbia University) This conference presented and discussed the first public findings from a project supported by Columbia's Harriman Institute and the Carnegie Corporation of New York. Rather than trying to predict how or when Vladimir Putin will eventually leave the halls of Kremlin power, the goal was to assess what will happen inside Russia in the aftermath of his inevitable departure, and what the implications will be for Russia and the world. This conference brought together top academic analysts with deep knowledge of particular sectors of the Russian political system.

#### **Tetiana Levitskaia**

September 3, 2024–October 17, 2024 Selections from the Kolodzei Art Foundation

This exhibition featured a selection of works on paper and paintings by the prominent nonconformist artist Tatiana Levitskaia (b. 1944 in Kyiv, Ukraine). It offered a glimpse into her creative process and celebrated her artistic journey. Levitskaia studied design at the Moscow Textile Institute. In 1969, Levitskaia met her future husband, artist Borukh (Boris Shteinberg,1938-2003). Drawn to experimental art, Tatiana and Borukh were part of Moscow's lively artistic underground.

#### Children of the War

October 28, 2024–Deecmber 12, 2024 Photographs, drawings, and text by Michel Gérard and Marina Tëmkina

This exhibition focused on the traumatic consequences of war for children's psyches. What images and feelings does our conscience carry throughout life? Why do we, the children of the war and post-war period baby boomers, return to this experience of the family and collective traumas again and again? The exhibition included paintings by Michel Gérard as well as Marina Tëmkina's cycle of twelve texts "Children Who Starve" about the psychological self-negation as a result of food deprivation that children of the war experience.





#### Lens on a Century

January 21, 2025–March 14, 2025 Curated by Edward Kasinec Documentary Photographic Albums From the Slavic, East European and Eurasian Collections of The Hoover Institution Library & Archives, Stanford University

The Slavic, East European and Eurasian archival collections of the Hoover Institution Library & Archives have long been regarded as one of the premier resources of their kind outside the homelands. Perhaps less well appreciated are Hoover's extraordinary holdings of tens of thousands of photographs, both "loose" prints and in hundreds of collector-assembled albums found in collections relating to the vast expanse of the Caucasus, the Balkans, Eastern and Central Europe, the Baltics, and of course, Russia and the former Soviet Union. This exhibit in twenty-five panels sought to provide a "lens" on a period from circa 1899 to the post-World War II era as prismed through a necessarily very small selection of documentary photographic albums chosen from the hundreds found within the Hoover's archival collections.


#### An infinite archive

March 25, 2025-May 16, 2025 Elidor Mëhilli

Elidor Mëhilli's work captured Tirana's bewildering transition from communist-era central planning to neoliberalism. The collapse of the party-state in the early 1990s triggered a mass migration to the periphery of the city, which was ill-equipped to handle it. Ordinary residents transformed into amateur architects, converting ground floors into shops and adding illegal floors to prefabricated blocks. Various governments have tried to dominate the city, but Tirana tends to defy them, pursuing an unruled life.

In a process that began with earlier shows at galleries at Cornell University (2005) and Princeton University (2007), Mëhilli explored the transformation of familiar places of his teenage years, like the raw graffitied façade of a housing block that served as a backdrop to a playground and a mysterious kiosk stuffed with old books that has somehow survived the decades of turmoil.

#### Elizabeth Kridl Valkenier (1926-2024)

Adjunct Associate Professor Emerita of Art History and Archaeology

Beloved colleague, mentor, teacher, and friend, Elizabeth Kridl Valkenier, passed away peacefully at the Cape Cod home of her daughter, Lisa Valkenier, on November 13, 2024. It was her 98th birthday.

Elizabeth Kridl, daughter of Manfred Kridl, renowned scholar and professor of Polish Literature at Wilno University, came to the United States in 1941 with her mother and brother, to join her father who had left Poland and was then teaching at Smith College. Kridl left Smith College in 1948, the same year that Elizabeth graduated from the college, for Columbia University, where he held the Adam Mickiewicz chair until his retirement in 1955. Elizabeth went to Yale University and earned her M.A. in history (1949). It was at Yale that she discovered her love for Russian history while taking a seminar with George Vernadsky. Elizabeth pursued her study of Russian history at Columbia—the seminar on medieval Russia with Michael Cherniavsky led to her choosing a topic in art history for her dissertation. She earned the Certificate of the Russian Institute in 1951, and received her Ph.D. in History at Columbia in 1973.

Valkenier's three seminal books on Russian art history were all published under the aegis of Studies of the Russian/Harriman Institute. In the first, Russian Realist Art. The State and Society: The Peredvizhniki and Their Tradition (Ardis, 1977), her considerably revised and expanded dissertation, Valkenier ventured beyond the Peredvizhniks' heyday and traced their influence into the twentieth century as a model for socialist realism.

Valkenier's initial contacts and experiences in the USSR date back to a 10-day Intourist trip to Moscow in 1958. She returned the following year as a guide for the American Exhibit, an experience she writes about in "Cultural Exchanges: A Personal Reflection" (Harriman Magazine, Fall 2021). Valkenier returned to Moscow in 1967 in the capacity of research assistant to Philip Mosely, director of the European Institute and Valkenier's cherished mentor. With Mosely's introductions she met highly placed Soviet experts with whom she maintained contact for the next 30 years, which ultimately yielded her second book, *The Soviet Union and the Third World: An Economic Bind* (Praeger, 1983).

Her next book in art history, *Ilya Repin and the World of Russian Art* (Columbia University Press, 1990), is not simply a biography of the foremost Peredvizhnik, but also an insightful look at the distorting lens of Soviet historiography. *Valentin Serov: Portraits of Russia's Silver Age* (Northwestern University Press, 2001), a study of Repin's best-known pupil set against the background of the transition from realism to Russian modernism and the interplay of art and social history during Russia's Silver Age, completes the cycle. In 2008, Valkenier, together with Wendy Salmond, was guest editor of a special issue of Experiment: A Journal of Russian Culture: Russian Realist Painting. The Peredvizhniki: An Anthology, a compilation of documents in English translation.

The year 2014 saw the publication of From Realism to the Silver Age: New Studies in Russian Artistic Culture: Essays in Honor of Elizabeth Kridl Valkenier (Northern Illinois University Press). Edited by Rosalind Blakesley and Margaret Samu, the volume collects 13 essays by Western and Russian scholars, who develop major themes inspired by Valkenier's work.


